The Special Bids and Awards Committee II (SBAC II) hereby issues this Supplemental Bid Bulletin to inform the prospective Bidders of the following:

 Amended checklist of documents comprising the Eligibility and Technical Requirements

Eligibility Documents CLASS A DOCUMENTS-

- PhilGEPS Certificate of Registration of Membership under Platinum Category in accordance with GPPB Circular 03-2016, except for foreign bidders participating in the procurement by a Philippine Foreign Service Office or Post, which shall submit their eligibility documents under Section 23.1 of the IRR, provided, that the winning bidder shall register with the PhilGEPS in accordance with section 37.1.4 of the IRR;
- Statement of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid;
- Statement of the Bidder's SLCC similar to the contract to be bid, in accordance with ITB Clause 5.4;
- PCAB License and Registration;
- A valid special PCAB License in case of joint ventures, and registration for the type and cost of the contract for the Project; and
- NFCC Computation in accordance with ITB Clause 5.5.

CLASS B DOCUMENTS-

 If applicable, Joint Venture Agreement (JVA) in accordance with ITB Clause 5.5

Technical Documents

- Bid security in accordance with ITB Clause 18. If the Bidder opts to submit the bid security in the form of:
 - (1.1) a bank draft/guarantee or an irrevocable letter of credit issued by a foreign bank, it shall be accompanied by a confirmation from a Universal or Commercial Bank; or
 - (1.2) a surety bond, it shall be accompanied by a certification by the Insurance Commission that the surety or insurance company is authorized to issue such instruments.
- Project Requirements, which shall include the following:
 - (2.1) Organizational chart for the contract to be bid;
 - (2.2) List of contractor's personnel (e.g., Project Manager, Project Engineers, Materials Engineers, and Foremen), to be assigned to the contract to be bid, with their complete qualification and experience data. These personnel must meet the required minimum years of experience set in the BDS; and
 - (2.3) List of contractor's major equipment units, which are owned, leased, and/or under purchase agreements, supported by proof of ownership, certification of availability of equipment from the equipment lessor/vendor for the duration of the project, as the case may be, which must meet the minimum requirements for the contract set in the BDS.
- Sworn statement in accordance with Section 25.3 of the IRR of RA 9184 and using the form prescribed in Section VIII. Bidding Forms.
- 2. Amended checklist of documents comprising the Financial Proposal:
 - Financial Bid Form, which includes bid prices and the bill of quantities, in accordance with ITB Clauses 15.1 and 15.3; and
 - Any other document related to the financial component of the bid as stated in the BDS such as:
 - a. Bid prices in the Bill of Quantities:
 - b. Detailed estimates, including a summary sheet indicating the unit

prices of construction materials, labor rates, and equipment rentals used in coming up with the Bid; and

- c. Cash flow by quarter or payment schedule
- To maintain the submission of prospective bidders of one (1) original and six (6) copies of the first and second components of bid.
