- Bidding for the above item/project will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding for the above item/project is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- Interested bidders may obtain further information from PCSO Bids and Awards Committee and inspect the Bidding Documents at the address given below from 8:00am to 5:00pm.
- 5. A complete set of Bidding Documents for the above item/project may be acquired by interested Bidders on *September 20, 2017 (Wednesday) up to 8:30 am of October 10, 2017 (Tuesday)* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of *Ten Thousand Pesos (P10,000.00)* per set.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- The PCSO will hold a Pre-Bid Conference for the above item/project on September 28, 2017 (Thursday) at 9:30am, BAC Room, 3/F Conservatory Building, 605 Shaw Blvd., Mandaluyong City. which shall be open to prospective bidders.
