2. In response to the query raised during the Pre-Bid Conference, please be informed that the Bids and Awards Committee hereby announces that financial bids/proposals should be compliant with DOLE Department Order No. 150-16, Series of 2016 or the *"Revised Guideline Governing the Employment and Working Conditions of Security Guards and Other Private Security Personnel in the Private Security Agency"* requiring an Agency Fee of 20%. Thus, the breakdown of rates per Security Guard should reflect an Agency Fee of not less than 20%.
3. In the computation of the financial bid/proposals, the latest wage order considered by the PCSO in its ABC shall be included and used as the cut-off date on a per area basis as indicated below:
