2. The submission of eligibility documents thru courier services is allowed provided that the format in the signing and sealing of eligibility documents is properly observed. In determining the timely submission of bids, the actual date and time of receipt duly stamped by the Secretariat of the Bids and Awards Committee shall prevail.
3. The phrase "when the types and fields of consulting services in which the foreign consultant wishes to engage involve the practice of regulated professions, the foreign consultant must be authorized by the appropriate GoP professional regulatory body specified in Clause 1.2 to engage in the practice of those professions and allied professions: Provided, however, That the limits of such authority shall be strictly observed" found under Clause 1.3 (b) of the Eligibility Data Sheet, page 13 of the Eligibility Documents; Paragraph A (2)(b) of the Checklist of the Eligibility and Technical Requirements, page 15, and Paragraph A (3)(5) of the said checklist shall not apply to this project.
4. For the purpose of complying with the eligibility requirement of the project, Foreign Bidders may be eligible to participate in this project provided that Filipino Consultant/s should be among its project team for legal, financial or technical aspect to complement its IT/Gaming expertise. Such Filipino consultants shall comply with applicable legal requirements under the procurement rules. The statement of nationality of the IT/GC's key personnel and consultants shall be submitted in the 2<sup>nd</sup> Stage – Technical Component of its bid.
